No. GJ-N,WR.WS.&K/GN.12/2010/GAB/1279/10/E In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Executive Engineer (Civil), Gujarat Service of Engineers, Class-I, Recruitment rules, 1979, namely:-

1. These rules may be called the Executive Engineers (Civil) Gujarat Service of Engineer, Class-I Recruitment (Amendment) Rules, 2010.

2. In the Executive Engineer (Civil) Gujarat Service of Engineers Class-I, recruitment rules, 1979, in rule 2 for clause (b) and proviso thereunder, the following shall be substituted, namely:-

“(b) by promotion of a person of proved merit and efficiency from amongst the persons who,-

(i) have worked for not less than eight years in the Cadre of Deputy Executive Engineer, Class II under the Narmada, Water Resources, Water Supply and Kalpsar Department; and

(ii) have passed the qualifying examination for Computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules 2006: and

(iii) possess the degree or diploma in Civil Engineering, obtained from any of the

Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared to be deemed as University under section 3 of the University Grant Commission Act, 1956; or possess an equivalent qualification recognised by the Government.

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub-clause (i) above.

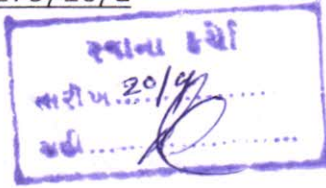
