In exercise of the powers conferred by sub-section (1) of section-19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act-2013(30 of 2013) (hereinafter referred to as "the Act"), the Government of Gujarat hereby notifies to all the person or persons interested, that the Government of Gujarat is satisfied with the report submitted by the Deputy Collector and Land Acquisition Officer, Narmada Yojana, Gandhidham under sub-section (2) of section 15 of the Act and it is decided to Acquire the land at Layja Mota Village of Mandvi Taluka of Kachchh District which has more particularly been specified in the SCHEDULE-Annexed hereto for public purpose of construction of **Kachchh Branch Canal**.

2. This declaration made by way of notification issued under sub-section (1) of section 19 of the Act is applicable to all the persons interested in this land.
3. The layout and plan of the land/lands proposed to be acquired is kept for inspection by Public in the Office of Deputy collector and special land Acquisition Officer, Narmada Yojana, Narmada Bhavan, Hostel Building , Block no.3/8, Ward 5/B, Opp. Rambhag Hospital , Rampath Raod, Adipur-kachchh on any working day during the office hours.
4. As per Narmada, Water Resources, Water Supply & Kalpsar Department, Government of Gujarat, and Notification No: **LAQ/2019/kachchh/295/190/M, Dt.24/10/2019** the same land / lands which are proposed to be acquired is exempted from Social Impact Assessment study.
