In exercise of the powers conferred by sub-section (1) of section-19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act-2013(30 of 2013) (hereinafter referred to as "the Act"), the Government of Gujarat hereby notifies to all the person or persons interested, that the Government of Gujarat is satisfied with the report submitted by the Deputy Collector and Land Acquisition Officer, Narmada Yojana, Bhachau under sub-section (2) of section 15 of the Act and it is decided to Acquire the land at Ambaliyara Village of Bhachau Taluka of Kachchh District which has more particularly been specified in the SCHEDULE-A annexed hereto for public purpose of construction of Approach Road of approach road of Vandhiya Sub Branch Canal.

2. This declaration made by way of notification issued under sub-section (1) of section 19 of the Act is applicable to all the persons interested in these land.




