The Government of India has received a Credit (Credit Ln 7995-IN/Cr 4848 IN / Cr 4848-IN) from the International Development Association from the International Bank for Reconstruction and Development in various currencies towards the cost of PMGSY Rural Road Project II and it is intended that part of the proceeds of this credit will be applied to eligible payments under the contracts for which this Invitation for Bids is issued.

2. The Deputy Director, GERI, Vadodara, Gujarat now invites online bids from eligible bidders for supply of Laboratory Testing Equipments and special equipments listed in Annexure-I, in separate lots.

3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures agreed with World Bank. The Provisions in the Instructions to Bidders and in the General Conditions of contract are based on the provisions of the World Bank Standard Bidding Document – Procurement of Goods.
