PREAMBLE :

Sardar Sarovar Narmada Project, Gujarat is a multipurpose interstate project and is currently in its advance stage of completion. For expeditious completion of the project the role of key technical manpower i.e. Executive Engineer, Deputy Executive Engineer and Assistant Engineer is critical and vital. In consideration of scarcity of these vital technical manpower than that of the requirement it was felt necessary to evolve a policy, so as to avail the services of these retired personnel till the availability of the personnel shall be met.

RESOLUTION :

After careful consideration Government is pleased to authorize Chairman and Managing Director of Sardar Sarovar Narmada Nigam Limited for the appointment of retired Executive Engineers, Deputy Executive Engineers and Assistant Engineers in SSNNL for further period of two years. The terms and conditions mentioned as here-under:

R.1 Resource Person :

The officers who are retired as Executive Engineer with 8 year tenure from State/Central Government shall be considered as Group-R1 Resource person and shall be paid remuneration of Rs. 1300/- per working day.

The Maximum remuneration to each resource person shall be limited to 300 days per annum.

R.2 Resource person :

The officer who are retired as Deputy Executive Engineer/Assistant Engineer with 8 year tenure from State/Central Government shall be considered as Group R-2 Resource Person and shall be paid remuneration of Rs. 650/- per working day.

The maximum remuneration to each resource person shall be limited to 300 days per annum.

Further, the personnel considered for such appointment as Resource Person R1 or R2 shall not have any on-going departmental inquiry and the Resource Personnel should not have been punished during the last two years of his service.

General Conditions :

1. The remuneration shall be payable for every day spent on work. The day shall be defined as the time spent on work of State of Gujarat. A half working day may be calculated as half the day and any other shorter period shall be neglected. The basis for payment shall be the diary of the duty performed by the person so engaged and certified by the next reporting officer, not below the rank of the officer engaged for the work.
2. The remuneration to the Resource person shall be paid after deducting income tax as per prevailing norms.
3. The Service Tax to be paid shall be borne by the Resource Persons.
4. Actual Transportation Expense to the place of work or any journey related to SSNNL work will be paid as per prevailing Government of Gujarat rules.
5. The maximum remuneration to each resource person shall be limited to 300 days per annum.
